d. Environment

- **Highways – Local issues with speeding, parking and traffic**
Traffic count taken last year. Waiting on feedback from the Council.
- **Trees on Gunnersbury Lane**
Requested that missing paving stones be replaced where trees had been vandalised on the section of Gunnersbury Lane between Avenue Road and Mill Hill Road. The Council proceeded with replacing the trees. One tree along the section has already been vandalised.
- **Heritage Road Signs**
Replacement signs for Avenue Crescent and Mill Hill Road still pending.

d. Environment (contd)

- **New Benches on Crown Street**

At the request of the MHPRA, two benches were installed on Crown Street opposite the pocket garden.

- **Bulbs Planted**

The MHPRA was successful in applying to the Metropolitan Public Gardens Association for free bulbs and members helped plant them in the Pocket Garden and the entrance to Mill Hill Gardens.

- **Litter Picking**

Area covered extended beyond Mill Hill Park and increase in number of people joining this initiative.
